WAIVER AND RELEASE AGREEMENT
(Please read carefully before signing)

This is a release of liability and waiver of certain legal rights

In consideration for my being permitted to participate in the activities of North Valley Sportsman Club (NVSC), I agree to the following Waiver and Release:

I acknowledge that target shooting and being present near discharging firearms has inherent risks, hazards, and dangers for anyone, particularly in a wilderness environment. These risks can be managed, but never eliminated on an active and public gun range facility.

I UNDERSTAND THAT THESE RISKS, HAZARDS, AND DANGERS INCLUDE WITHOUT LIMITATION:

1. The risk of handling firearms and being near others that have firearms in their possession.
2. The risk of ear and eye damage. Ear and eye protection is always required.
3. The risk of injury from ammunition, clay targets, shot, bullets, bullet fragments, and ricochets from other guns.
4. Physical encounters with wildlife, animals, and insects.
5. Inclement weather conditions.

I understand the risks, hazards, and dangers of the use of firearms and have had the opportunity to discuss them with North Valley Sportsman Club. I understand that these activities may require good physical skill and knowledge necessary for me to engage in these activities safely. I understand that I have responsibilities to always exercise reasonable caution and safe gun handling practices. I understand that I must obey all posted rules of NVSC.

My participation in this activity is purely voluntary. No one is forcing me to participate, and I elect to participate despite the risks. I AM VOLUNTARILY USING THE SERVICES OF NVSC, WITH FULL KNOWLEDGE OF THE INHERENT RISKS, HAZARDS, AND DANGERS INVOLVED AND HEREBY ASSUME AND ACCEPT ANY AND ALL RISKS OF INJURY, PARALYSIS OR DEATH.

Lastly, I, for myself, my heirs, successors, executors, and subrogates, hereby KNOWINGLY AND INTENTIONALLY WAIVE AND RELEASE, INDEMNIFY, AND HOLD HARMLESS, NVSC, THEIR DIRECTORS, OFFICERS, AGENTS, AND VOLUNTEERS from and against any and all claims, actions, causes of actions, liabilities, suits, expenses (including reasonable attorney's fees) which are related to, arise out of, or are in any way connected with my participation in this activity including, but not limited to NEGLIGENCE of any kind of nature, whether foreseen or unforeseen arising directly or indirectly out of any damage, loss, injury, paralysis, or death to me or any property as a result of my engaging in these activities or the use of these services, or equipment, whether such damage, loss, injury, paralysis, or death results from negligence of NVSC, or some other cause. I, for myself, my heirs, my successors, executors, and subrogates, further agree not to sue NVSC as a result of any Injury, paralysis, or death suffered in connection with my use and participation in the activities of NVSC. I HAVE CAREFULLY READ AND CLEARLY UNDERSTAND AND VOLUNTARILY SIGN THE WAIVER AND RELEASE AGREEMENT.
